7. **Aims & Objectives**

The course has two primary aims: (i) To study the sound system and pronunciation features of English, both segmental and suprasegmental, based on internationally accepted models (such as Received Pronunciation); (ii) To discuss and evaluate theoretical and pedagogical approaches to the acquisition and teaching of English pronunciation in an ESL/EFL context. A secondary aim is to raise the students' awareness of their own pronunciation and the potential for improvement.

8. **Course content**

- (1) Recap: Basic concepts in Phonetics and Phonology
- (2) Classification and transcription of speech sounds
- (3) The English sound system (I): Vowels
- (4) The English sound system (II): Consonants
- (5) Allophonic and phonotactic rules; Syllable structure
- (6) Word stress, rhythm and intonation

- (7) Acquisition of second-language phonology: Transfer (cross-linguistic influence); markedness theory
- (8) Issues and problems in the acquisition of English phonology by L2 learners
- (9) Pronunciation models for English as a world language; the Lingua Franca core
- (10) Listening comprehension; Accents of English
- (11) Techniques for the teaching of pronunciation
- (12) Identifying and analysing learners' pronunciation problems

9. Course Intended Learning outcomes (CILOs)

CILO	By the end of the course, students should be able to:
CILO1	Transcribe English sounds accurately using the International Phonetic Alphabet, and articulate these sounds clearly and intelligibly
CILO2	Evaluate theoretical and pedagogical issues in the acquisition of second-language (L2) phonology
CILO3	Analyze the pronunciation features of L2 learners with reference to L2 acquisition theories
CILO4	Design teaching strategies and materials for the acquisition of English pronunciation by L2 learners
